*I/We request that you transfer to Citibank Singapore Limited, and that Citibank Singapore Limited accept the transfer of, my/our Account, with effect on and from the Effective Date, in consideration for which, I/we:

1) Agree that on and from the Effective Date, all of the rights, title, interests, benefits, obligations and liabilities of Citibank, N.A., UAE in connection with the Account and all Related Agreements (as hereinafter defined), shall be transferred to, arise in favour of, bind and may be relied and acted upon by Citibank Singapore Limited to the same extent as if Citibank Singapore Limited had been originally a party to, was originally the beneficiary or otherwise had the benefit (whether expressly or impliedly) of and/or was the addressee or recipient of, the Account and all of such related Agreements;

2) Agree that Citibank, N.A., UAE shall be fully discharged and released from all of its obligations and liabilities in connection with the Account and the Related Agreements so transferred by it but shall retain all rights, title, interests, benefits, obligations and liabilities in connection with the Account and Related Agreements not so transferred by it;

3) Agree that the terms and conditions attached as Appendix I to this letter shall govern my/our Account subsequent to the Transfer to Citibank Singapore Limited. Subsequent to the transfer of my/our Account to Citibank Singapore Limited, I/we hereby authorize the transfer and disclosure of any information relating to me/us or the Account(s), to and between Citibank Singapore Limited and Citibank, N.A. (together "Citibank") and their respective branches, subsidiaries, representative offices, affiliates and agents and third parties selected by any of them and any other person to whom Citibank out-sources the performance of any or its functions (including, but without limitation, any third party service provider (each a "Service Provider") engaged by Citibank to perform out-sourced functions) wherever situated, for confidential use (including but not limited to for use in connection with the provision of any product or services and dealings in securities on The Singapore Exchange Securities trading Limited or any other relevant authorities and agencies pertaining thereto). I/We acknowledge and are aware that each of Citibank and any of its respective branches, subsidiaries, representative offices, affiliates, agents or third parties selected by any of them or a Service Provider (the "parties") shall be permitted to further disclose information relating to me/us or the Account(s) to third parties for confidential use including but not limited to disclosure to other sub-contactors or agents of any of the Parties and/or disclosure pursuant to a court order, police investigations and commercial prosecutions for tax and other offences.

I/We consent to the disclosure by Citibank N.A. UAE to Citibank Singapore Limited or any other person of any and all information relating to me/us, the Account, the provision of any banking services and/or products to me/us from time to time in connection with any of the Account and Related Agreements, and any other information whatsoever which may be required in connection with the Transfer.

In this letter:

"Related Agreements" means any agreements, documents and/or instrument(s) made or entered into connection with the Account and any acknowledgements (including but not limited to risk disclosure statements and acknowledgements), information (including but not limited to information provided in respect of risk profiling), instructions, orders, directors, mandates, powers and/or authorities of all descriptions given and/or provided by me/us, to Citibank, N.A., UAE for the purpose of the provision of services and/or products to me/us from time to time in connection with the Account;

This letter shall be governed in accordance with the laws that are applicable to the Account and the related Agreements save that Clause 3 of this letter shall be governed by, and construed in accordance with, Singapore law.
